To the Constables of the Town of Orange, in the County of Franklin:

GREETING:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote on Town affairs, to meet at Ralph C. Mahar, football field, located at 507 South Main Street, in said Orange on Monday, the fifteenth day in June 2020, at six in the evening, then and there to act on the following articles:

**ARTICLE 1: SNOW & ICE**

To see if the Town will vote to transfer the sum of \$83,211.14 from Free Cash to Snow and Ice to cover the deficit; or take any other action relative thereto.

**ARTICLE 2: PRIOR YEAR BILL – SEWER ENTERPRISE EXPENSES**

To see if the Town will vote the sum of \$498.00 from Sewer Enterprise Expenses to pay Pan Am Southern, LLC in accordance with M.G.L. c.44, §64, Appropriation to Pay Uncertain Unpaid Bills of Previous Years, or take any action relative thereto.

**ARTICLE 3: SEWER REFUND**

To see if the Town will vote to appropriate from Sewer Retained Earnings the sum of \$3,019.57 to refund Sewer FY18 and FY19 overbilling to K.J. Mack Realty Trust in accordance with M.G.L. c.44, §64, Appropriation to Pay Uncertain Unpaid Bills of Previous Years, or take any action relative thereto.

**ARTICLE 4: PRIOR YEAR BILL – FIRE DEPARTMENT**

To see if the Town will vote the sum of \$264.79 from Fire Department Expense to pay Moore Enterprises in accordance with MGL Chapter 44, Section 64-Appropriation to Pay Certain Unpaid Bills of Previous Years, or take any action relative thereto.

**ARTICLE 5: PRIOR YEAR BILL – FIRE DEPARTMENT**

To see if the Town will vote to transfer a sum of money from Fire Department Wages to Fire Department Training Wages 001-224-5148-1000, or take any action relative thereto.

Hereof fail not, and make due return of this Warrant with your doings thereon, to the Town Clerk, at the time and place of meeting as aforesaid.
