Permit fee is based on entire "Estimate Cost of Construction" Proof of costs - signed contract	
Minumun construction cost for all new buildings and structures will be determined from values as listed in the most current ICC Building Valuation Data. ICC Building Valuation Data is updated every six months.	
If project is not related to new sq. ft., the fee will be based on a sound estimate of the cost of construction.	
Once the cost of construction is determined, the fee is based on \$10 per \$1,000 of value.

<u>PLUMBING</u>	
All new Residential 1 or 2 Family <i>(Covers all fixtures & includes 3 inspections; any additional inspections will be \$15)</i>	\$300 per permit
All Residential remodel work <i>(Includes one fixture/Appliance)</i>	\$90 per permit plus \$15 per additional fixture
All Commercial Work Under 5,000 sq ft <i>(New or remodel; includes one fixture/Appliance)</i>	\$225 per permit plus \$15 per additional fixture
All Commercial Work Over 5,000 sq ft <i>(New or remodel; includes one fixture/Appliance)</i>	\$350 per permit plus \$15 per additional fixture
